

Labor Union Activity in 2022: A Year of Resurgence and Struggle

2022 witnessed a notable increase in unionization campaigns, extending beyond traditional strongholds into sectors like technology and retail. High-profile victories at companies like Amazon and Starbucks captured national attention, signaling a broader shift in worker sentiment and increasing support for labor unions.

Skilled trade unions, particularly in construction, were at the forefront of labor actions. These unions, representing electricians, plumbers, machinists, and other tradespeople, pushed for better wages, safer working conditions, and more robust benefits.

John Deere strike: The strike at John Deere, which began in late 2021 and continued into early 2022, involved over 10,000 workers. Members of the *United Auto Workers (UAW)* union demanded higher wages, improved pension plans, and better job security. The strike concluded with a new agreement that met many of the workers' demands.

Machinists and Aerospace Workers: Workers in the aerospace sector, including those at major companies like Boeing, engaged in strikes and negotiations. The International Association of Machinists and Aerospace Workers (IAMAW) secured better contracts addressing wage increases and job security.

Transportation unions were particularly active in 2022, reflecting widespread dissatisfaction with working conditions and compensation.

CSX Railroad Workers: Represented by unions including the Brotherhood of Locomotive Engineers and Trainmen (BLET) and SMART Transportation Division, they engaged in strikes and work stoppages to demand better pay, safer working conditions, and more predictable schedules. The implementation of "precision-scheduled railroading" (PSR) had led to workforce reductions and more demanding schedules, exacerbating worker grievances.

Teamsters at UPS and Sysco: The International Brotherhood of Teamsters (IBT), representing workers at UPS and Sysco, was involved in several strikes and labor actions. Workers demanded higher wages, better health benefits, and improved working conditions, highlighting the essential role of logistics workers in maintaining supply chains.

Labor Caucus Introduces Richard L. Trumka PRO Act to Empower Workers and Strengthen Unions

On February 28, 2023, the Labor Caucus introduced the Protecting the Right to Organize (PRO) Act to enhance workers' rights to unionize, reverse anti-union policies, and ensure fair union elections.

They released the following statement: "This critical, bipartisan legislation will ensure all workers have the right to organize and collectively raise their voices for dignity and respect. The PRO Act would reverse decades of anti-union policies, strengthening the labor movement. It empowers workers to join a union, holds companies accountable for obstructing unionization efforts by creating enforceable penalties, and ensures free and fair union elections. This bill will help make sure every worker that wants to join a union can. Union membership is an essential pathway to the middle class and with the PRO Act, we can ensure every worker's rights are protected."



Study Reveals Top Causes of Death Among Construction Workers, Highlighting Health Risks Beyond the Job Site

A comprehensive study by the Center for Construction Rersearch and Training (PWR) emphasizes the need for comprehensive health strategies that prioritize both immediate safety and long-term health concerns linked to occupational exposures for construction workers.

A new study led by Amber Brooke Trueblood has unveiled significant insights into the leading causes of death among construction workers, encompassing those actively employed, retired, or no longer in the workforce. This analysis uses data from the National Center for Health Statistics to explore health risks beyond immediate job-related injuries, highlighting broader mortality trends within this sector in 2020.


The research reveals that older construction workers, particularly those aged 65 and older, predominantly succumb to natural causes, while middle-aged workers (35-64 years) were mostly impacted by COVID-19. Notably, younger workers (16-34 years) faced a different

risk, with accidental poisoning from narcotics and hallucinogens being the leading cause of death. These findings illustrate varied health risks across different age groups within the construction industry.


This study points to the critical need for holistic health strategies that address not only immediate safety on construction sites but also long-term health issues possibly related to occupational exposures. By extending focus beyond the workplace, the research advocates for enhanced healthcare and preventive measures to mitigate the wide range of health challenges that construction workers face throughout their lives.
