White House Measures to Combat Extreme Heat Are Insufficient and Require Urgent Improvement

The National Council for Occupational Safety and Health (National COSH) has declared the recent measures announced by the White House to protect workers from extreme heat as insufficient. The organization is calling for more aggressive actions to address the deadly risks associated with extreme heat, which are intensified by climate change.

Insufficient Measures in the Face of Growing Threats

Jessica E. Martinez, co-executive director of National COSH, expressed concerns in a blog post, stating, "Tragically, workers are getting sick and dying every day from the extreme heat driven by climate change." She called for bold actions from the President, Congress, federal OSHA, and state officials to reduce risks and save lives.



Marcy Goldstein-Gelb, also a co-executive director, emphasized the preventable nature of heat-related illnesses and deaths. "We are not helpless in the face of the triple-digit temperatures that are breaking thermometers all over the globe," she said.

Call for Stronger Regulatory Actions

President Biden has increased enforcement and inspections for heat safety violations under the 'general duty' clause of the U.S. Occupational Safety and Health Act. However, Martinez and Goldstein-Gelb insist on specific standards for heat stress to offer better protections.


Martinez urges employers not to wait for the regulatory process to conclude before taking preventive measures, warning that without them, more workers will become sick and die from extreme heat.

"Millions of workers who build our homes, bring food to our tables, and provide other essential goods and services are at risk right now," Martinez emphasized. "Our government, at all levels, must respond – right now."

Specific Recommendations

National COSH leaders outlined steps to enhance worker protection:

- Immediate Emergency Temporary Standard (ETS) on heat stress by federal OSHA.
- Congressional mandate for an interim federal OSHA standard on heat stress.
- · Accelerated creation of a permanent federal safety standard.
- Swift establishment of state-level standards in the 45 states currently lacking them.



Practical Measures to Protect Workers

National COSH advocates for several practical, evidence-based measures to protect workers from extreme heat:

- Adequate rest breaks
- Plentiful fresh water
- Access to shade
- Reduced work schedules
- Shifting work to cooler parts of the day
- Buddy systems to ensure no worker is left alone

According to the COSH, these measures must be implemented now in all indoor and outdoor settings with extreme heat.



United Auto Workers (UAW) Strike: A Bold Move for Better Terms

On September 15, 2023, the United Auto Workers (UAW) initiated a historic strike against Ford, General Motors, and Stellantis to demand fair wages and job security.



Economic Demands: Central to the strike were demands for a 20% immediate wage increase, totaling a 46% rise over time, and the restoration of traditional pensions and retiree healthcare. UAW President Shawn Fain argued that these demands were justified by significant profit increases for automakers, which he claimed were unfairly benefiting executives and shareholders over workers.

Industry Changes and Job Security: The ongoing transition to electric vehicles (EVs) added urgency to the strike. The UAW sought assurances that new EV-related jobs would be unionized and offer wages and benefits comparable to traditional auto manufacturing roles. This was crucial to prevent job losses and wage reductions as the industry evolves.

Strategic Striking: Employing a strategic "stand-up" strike approach, the UAW initially targeted key plants to maximize pressure while conserving its strike fund. This method allowed the union to maintain momentum and visibility during the negotiations.
